



Children entering Kindergarten are due for booster doses of the following vaccines: MMR (measles, mumps, and rubella), polio, DTaP (diphtheria, tetanus and pertussis) and chickenpox.

The second dose of chickenpox is recommended, but not required for school attendance.

Children who recently moved to Oklahoma may need the hepatitis A vaccination. The Hepatitis A vaccine, which is required for students in all grades in Oklahoma, is not required in some other states. Students need at least one dose of hepatitis A vaccine to start school. A second dose is due six to 18 months later.


